#### **Privacy Policy**

This website is operated by Thorough Events Ltd ('TE', referred to as 'we', 'us', 'our', etc.) This Privacy Policy outlines the way in which we gather and use information relating to you, the user of the TE website. By using this website, you consent to the use (including transfer) of information as described below.

Your privacy is extremely important to us. Any personal information we gather from you will be used in accordance with the Data Protection Act 1998 and we will treat all your Personal Information as confidential (although we reserve the right to disclose this information in the circumstances set out below).

#### What information do we collect?

When you use this website, if you wish to use features that require you to register with us, we will ask you to input and will collect personal information from you such as your name, email address, postcode, country and a password ('Personal Information'). We may also collect, and our third party providers of advertisements and content may collect, information about where you are on the internet (e.g. the URL you came from, IP addresses, domain types like .co.uk and .com), your browser type, the country and telephone area code where your computer is located, the pages of our website that were viewed during your visit, the advertisements you clicked on, and any search terms that you entered on our website ('User Information'). We may collect this information even if you do not register with us.

We use cookies to keep track of your current session to personalise your experience and so that you may retrieve images at any time. You may experience technical difficulties in using this website if you have disabled cookies. Cookies are small text files containing identity codes, which are stored on your computer by your web browser. Cookies do not harm your computer but if you do wish to stop your computer accepting cookies, go to the help section of your web browser where you will find information on how to do this.

# How do we use your information?

We will keep your information on a secure server and we will fully comply with all applicable UK Data Protection and consumer legislation. In particular, we confirm that any Personal Information which you provide to us (or which is available on public registers) and any User Information from which we can identify you is held in accordance with the registration we have with the Data Commissioner's Office. We use your information only for the following purposes:

- · Maintaining a record of correspondence;
- For statistical or survey purposes to improve this website and the services to you and to recognise you when you return to our website:
- To serve website content and advertisements to you;
- To administer this website and to notify you about changes to our service;
- If you consent, to notify you of events, products or special offers that may be of interest to you (see below);
- For the detection of fraud
